SUPPLIER'S PERSONAL DATA PROTECTION RULES

DATA PROTECTION

1. The processing of personal data of the Staff or Workers provided by the Supplier for the management of the provision of services will be done according to Regulation (EU) 2016/679 of the European Parliament and of the Council, of April 27th, 2016 (hereinafter RGPD) and the Spanish Organic Law 3/2018, of December 5th, for the Protection of Personal Data and Guarantee of Digital Rights (hereinafter LOPDGDD) and any other data protection regulations. Both parties are considered responsible of the data provided, which will be processed for the purpose and legal basis of the management of the provision of services and the maintenance and development of business relationship based on both parties' commercial legitimate interest. Data will be kept for as long as the legal relationship is maintained or until the erasure for commercial purpose is requested. Once the legal relationship is concluded or the erasure is requested, the data will be kept available to the public administration, judges and courts for the time-barring of the actions that may apply to the processing. Both PARTIES have the right to access to their personal data, to correct inaccurate data or to request the erasure, limitation, opposition and portability of the same. For these purposes, a communication must be sent, expressly indicating the right to be exercised to the following mail rgpd@dogas.es. Additionally, the PARTIES are reminded that they have the right to claim to the Spanish Data Protection Agency and that they may object to the processing of data for commercial purposes.
2. In the cases in which the provision of the contracted services is necessary to access the facilities of DOGA by the Personnel or Workers of the SUPPLIER: then, according to the Spanish Royal Decree 171/2004, of January 30th that develops the article 24 of the Law 31/1995, of November 8th of the Prevention of Occupational Hazards for business activities purpose, the SUPPLIER shall provide to DOGA the personal data of such Personnel or Workers, doing a disclosure or data communication needed to comply with the legal duties. SUPPLIER guarantees to DOGA that its Personnel or Workers have been informed of the communication of their data to DOGA for the purpose of: Coordinating business activities, facilities access control and security, identifying to DOGA the Personnel or Worker's identity, the contact details, the purpose of the processing, the categories of data disclosed, the time limit for erasure and the existence of the right to request DOGA to access to the personal data processed, to correct inaccurate data, to request the erasure, limitation, opposition and portability of the data subject to transfer.
